The Reform Act of 1832 introduced some revolutionary changes in the representative system and franchise system of England. In the constitutional history of England, it proved to be an era of significance. Tory members named it a revolutionary act because it shook up the roots of ancient conventions. Famous historian, Trevelyan has called it, "The Modern Magna Charta". In fact the first Reform Bill was a great document of 82 provisions. The following were some of the significant effects of the Reform Act of 1832: 1. This Act enhanced the franchise threefold and the total number of the voters re The Representation of the People Act 1867, 30 & 31 Vict. c. 102 (known as the Reform Act of 1867 or the Second Reform Act) was a piece of British legislation that enfranchised part of the urban male working class in England and Wales for the first time. It took effect in stages over the next two years, culminating in full enactment on January 1, 1869. Before the Act, only one million of the seven million adult males in England and Wales could vote; the Act immediately doubled that number.
