Following his remarks, Mr. Comiskey answered questions from members of the audience. Supreme Court justices don't need to have an extensive background in the judicial branch, however. California Attorney General Kamala Harris is another name that has been floated as a possible Supreme Court nominee, although she's currently campaigning to replace Barbara Boxer in the US Senate. Normally, if a vacancy opens up on the court, the president will name a successor after a few weeks of consideration. At that p
