Business Source Corporate



Business Source® Corporate is designed to meet the diverse information needs of today's companies. This database contains full text from nearly 3,000 quality magazines and journals, including sources ranging from general business periodicals such as Fortune and Fast Company to trade publications such as Chemical Week and Electronic Business. The collection of titles also includes the top management journals such as Harvard Business Review, California Management Review and Academy of Management Perspectives. Additional sources include more than 1,400 country economic reports from EIU, Global Insight, ICON Group International, CountryWatch, etc.; more than 10,000 substantial company profiles; and 5,174 industry reports.

Business Source Premier (Ebscohost)



Business Source Premier provides full text for nearly 8,350 scholarly business journals and other sources, including full text for more than 1,100 scholarly business publications. This database offers information in nearly every area of business including management, economics, finance, accounting, international business, and more. Business Source Premier contains full text from the world's top management and marketing journals including Harvard Business Review, California Management Review, Administrative Science Quarterly, Academy of Management Journal, Academy of Management Review, Industrial & Labor Relations Review, Journal of Management Studies, Journal of Marketing Management, Journal of Marketing Research (JMR), Journal of Marketing, Journal of International Marketing, etc. The database also includes other sources of full text information such as country economic reports from the EIU, Global Insight, ICON Group and CountryWatch and detailed company profiles for the world's 10,000 largest companies.

This collection also includes a selection of titles in the more science-oriented fields of ecology, mathematics, and statistics.

Created by the National Library of Medicine, MEDLINE uses MeSH (Medical Subject Headings) indexing with tree numbers, tree hierarchy and explosion capabilities to search abstracts from over 4,800 current biomedical journals. Many people, myself included, feel that for all its advantages, the internet has precipitated a steady decline in the quality of writing. Anyone can write anything anywhere, and while that gives a voice to many who otherwise might not have a public forum to share what they have to say, it also makes it difficult and sometimes impossible to uphold any sort of standards.
