The intentionalist critics prepare the ground for a theory of literary discourse considered as a speech act, since it is known that the concept of intention is central to the analysis of speech acts. Such a theory of literary discourse should not overlook the role played by criticism in expanding the meaning of a text, and should go beyond a narrow definition of interpretation as the identification of the author's intention. Attacks on the objective view of literary interpretation, whether intentionalist or nonintentionalist, have taken a variety of forms and have been launched with a number of challenging arguments.
